<u>Legal strategies</u> <u>Introduction to legal strategies</u>

Property is the integral aspect of the civilized society. As said by Jeremy Bentham the protection provided to the property by the Government by creating appropriate legislations will determine the vigour of generation of property. More the protection more will be desire to create property boosting economy of citizens and economy of the country. Property includes tangible and intangible property and is earned by a person by inheritance, by his own hard work, by goodwill, by reputation and so on. A person in civil society has a right to defend and protect his property, protect possession of property, protect reputation, salary, opportunities to get higher salary by promotions, opportunities of inheritance by partition or by will and so on. These rights are to be exercised by seeking relief in the court of law. Same applies to the juristic person like company, firm, trust and others.

When a person is seeking relief before the court, he has to assert the facts on the basis of which he is seeking enforcement of his right. This assertion shall correlate with the remedy available in the statutory law. If he is seeking infringement of fundamental rights he has to assert about the acts of other party or the Government which infringes his fundamental right and entitle him for one of the writs from the High Court or Supreme Court as the case may be. Similarly, when a person is coming before the court as defendant or respondent, he has to raise appropriate defences permissible in statutory and procedural laws. This is the time to seek assistance of legal strategist.

Now anyone will say that the advocate from whom one is seeking legal assistance will take care of determining and applying legal strategies to protect or defend his right.
